

RESOLUTION NO. 04 - 2022

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE KEY LARGO WASTEWATER TREATMENT DISTRICT (“THE BOARD”) APPROVING THE REQUEST BY RICHARD AND DEBBIE KNODLE FOR THE EXCLUSION OF ONE TAX PARCEL FROM THE 2006 NON-AD VALOREM ASSESSMENT ROLL; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the tax parcels described in Section 1 below (“the Subject Tax Parcels”) are owned by Richard and Debbie Knodle (“the Owners”); and

WHEREAS, the Subject Tax Parcels were each assessed a System Development Charge (“SDC”) as reflected in the 2006 Final Assessment Resolution No. 20-06-2006, adopted on June 7, 2006; and

WHEREAS, the Monroe County Property Appraiser’s Office has aggregated the Subject Tax Parcels into one tax parcel assigned AK No. 1669105 (“the surviving tax parcel”) and deleted the tax parcel formerly assigned AK No. 1669113 (“the deleted tax parcel”); and

WHEREAS, in accordance with Section 10.05(a) of the Key Largo Wastewater Treatment District’s General Rules and Regulations (“KLWTD R&Rs”), the Board is authorized to exclude the deleted tax parcel from the District’s 2006 Non-ad Valorem Assessment Roll; and

WHEREAS, the Owners request that the deleted tax parcel be excluded from the 2006 Non-ad Valorem Assessment Roll; and

WHEREAS, pursuant to KLWTD R&Rs, Section 10.6(b), the Owners have certified that if they, or any subsequent owner, later desire wastewater service to be reinstated, the then current owner agrees to pay the full direct and indirect District costs of providing the same.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE KEY LARGO WASTEWATER TREATMENT DISTRICT THAT:

Section 1.

Section 2.

EXCLUSION FROM NON-AD VALOREM ASSESSMENT ROLL. The deleted tax parcel is hereby excluded from the Key Largo Wastewater Treatment District's 2006 Non-ad Valorem Assessment Roll.

Section 3.

EFFECTIVE DATE. This Resolution shall take effect upon adoption by the Board of Commissioners.

Section 4.

AUTHORIZATION OF DISTRICT OFFICIALS. The General Manager and/or his designee(s) are authorized to take all actions necessary to implement the terms and conditions of this Resolution.
