#### STANDARD FORM FOR PIGGYBACK CONTRACTS

The Key Largo Wastewater Treatment District ("District") enters into this "Piggyback" Contract with Reynolds Construction of Florida, LLC. ("Contractor"), under the terms and conditions hereinafter provided. The District and the Contractor agree as follows:

- 1. The Purchasing Policy for the District allows for "piggybacking" contracts. Pursuant to this procedure, the District is allowed to piggyback an existing government contract, and there is no need to obtain formal or informal quotations, proposals or bids. The parties agree that the Contractor has entered into a contract with the City of Marathon, said contract being identified as: "Continuing General Contracting Services Agreement," said original contract being referred to as the "original government contract".
- 2. The original government contract is incorporated herein by reference and is attached as Exhibit "A" to this contract. All terms and conditions set out in the original government contract (Exhibit "A") are fully binding on the parties and said terms and conditions are incorporated herein. The term City shall be deemed to refer to the Key Largo Wastewater Treatment District. All references to the "Continuing General Contracting Services Agreement" shall be deemed to refer to the KLWTD Emergency Services Contract.
- 3. Notwithstanding the requirement that the original government contract is fully binding on the parties, the parties have agreed to modify certain technical provisions of the original government contract as applied to this contract between the Contractor and the District, as follows:
  - a. Time period ("Term") of the Agreement: This continuing contract shall be for a term of three (3) years with one (1) two (2) year renewal at the discretion of the District. Actual completion of projects may extend beyond such term.
  - b. Insurance Requirements: Contractor shall provide a Certificate of Insurance naming the District as an "additional insured".
  - c. Any other provision that will be modified: N/A
  - d. Address change for the District: Notwithstanding the address and contact information for the government entity is set out in Exhibit "A", the Contractor agrees that he/she/it will send notices, invoices and will conduct all business with the District, attention of District Clerk, 103355 Overseas Highway, Key Largo, Florida 33037. The District's designated representative for this contract is Laura Weinstock, Project Administration and HR Coordinator, telephone number (305) 451-4019 and email laura.weinstock@klwtd.com.
  - e. Notwithstanding anything in Exhibit "A" to the contrary, the venue of any dispute will be in Monroe County, Florida. Litigation between the parties arising out of this contract must be in Monroe County, Florida in the Court of appropriate

jurisdiction. The law of Florida will control any dispute between the parties arising out of or related to this Piggyback Contract, the performance thereof or any products or services delivered pursuant to such contract.

- f. Notwithstanding any other provision in Exhibit "A" to the contrary, there shall be no arbitration with respect to any dispute between the parties arising out of this contract. Dispute resolution shall be through voluntary and non-binding mediation, negotiation, litigation in the Court of appropriate jurisdiction in Monroe County, Florida with parties bearing the costs of their own legal fees with respect to any dispute resolution including litigation.
- g. All other provisions in the original government contract (Exhibit "A") are fully binding on the parties and will represent the agreement between the District and the Contractor.

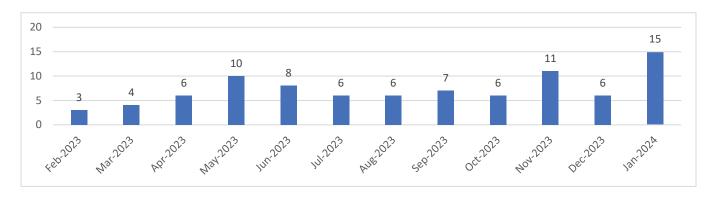

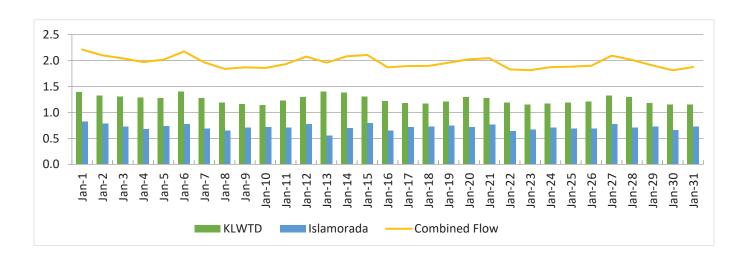

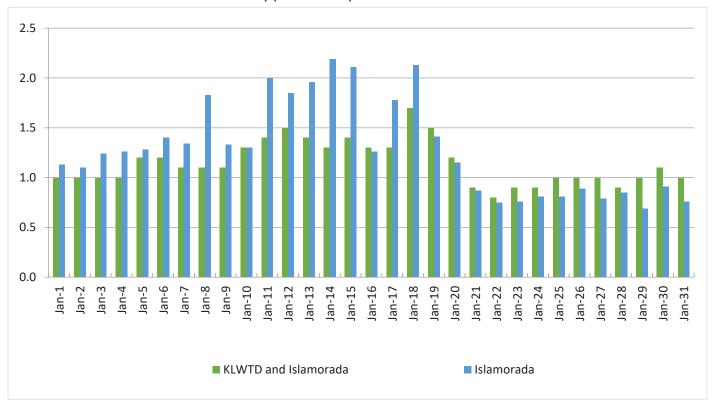
#### Daily Flow (MGD)

- Reynolds successfully replaced two influent valves during the January 16<sup>th</sup> shutdown and two remaining influent valves during the January 18<sup>th</sup> shutdown at Vacuum Station A.
- Reynolds and KLWTD shut down Vacuum Station J/K the night of January 24<sup>th</sup> for the successful replacement of four influent valves and for the installation of a six-inch ball valve on the effluent piping.
- Finally, Reynolds installed two effluent valves, the vacuum pump pipe tree, and exterior odor control lines at Vacuum Station J/K during the January 30<sup>th</sup> night shutdown.
- In the beginning of February, Reynolds began preparing the valves and piping material for upcoming shutdowns to install the new effluent valves and pipe tree at Vacuum Station D.

- The District piggybacked on a Marathon bid and awarded the Keys Holdings LLC project to Tropical Underground Contracting, LLC in the amount of \$375,555.75.
- Tropical Underground mobilized materials to the site on January 8<sup>th</sup>.
- A pre-construction meeting was held on Wednesday, January 10<sup>th</sup>, 2024 with the Contractor, WEC, and KLWTD.
- On January 11<sup>th</sup>, Tropical Underground commenced their site work. The crew began by potholing to determine underground conditions and identify any existing conditions that are in discrepancy to the as-built conditions.
- Tropical Underground revealed existing conditions that differed from the expected conditions and they proposed change order options to WEC.
- WEC reviewed the confirmed existing conditions and provided Tropical with an updated proposed site layout. WEC is awaiting a response from Tropical.

A meeting with the Archdiocese was held on January 16 <sup>th</sup> and a decision was made to extend the easement at Vacuum Station A.
Power Conditioning, Lightning Protection & Wiring Upgrades at WWTP	\$3,563,376 (Anticipated)	This project will provide protection from transient surges in power that can damage equipment and potentially cause overflows or inadequate treatment at the WWTP. Installation of a lightning protection system at the WWTP to further reduce the potential impacts due to electrical surges will also be included as part of the project scope. Upgrades to the existing power and instrumentation wiring at the WWTP includes the use of noncorrosive materials and moving wiring above-ground to prevent corrosion and failure. Weiler Engineering's Electrical Engineer conducted a site visit on January 18 <sup>th</sup> and began updating the electrical design and specifications for the project. A preliminary plan set is underway. This project is grant funded.
Direct Potable Reuse Demonstration Project	\$1,504,301.25 (Anticipated)	The District has budgeted funds for a demonstration project to produce potable water from the WWTP's treated effluent. 2021 Florida legislation established Direct Potable Reuse (DPR) as a preferred effluent disposal method and provides for DPR projects to be eligible for grant funding, treating WWTP effluent as an Alternative Water Supply. The District has applied for a planning grant for this project and has requested grant funding to be allocated for the design, permitting, and construction of the DPR demonstration project. Initial estimates indicate that the volume of water produced in the DPR demonstration project would be in the range of 150,000 to 250,000 GPD.

Grinder Pump Lateral Kits Replacement Project	\$590,625.00 (Anticipated)	This project is included in the District's FY24 budget. Previously, both plastic and brass check valves were installed as part of the C-905 and Unique Properties Grinder Pump Projects, as these were the standard valves recommended at the time. Both the existing check valves and plug valves have been experiencing failures. Currently, the check and plug valves are buried at the depth at which the laterals were installed, deeming it necessary to excavate down to the valves for service or replacement. This project includes installing the new 316 stainless steel lateral kits at a shallower depth and in meter boxes, allowing easy access without excavation for service and replacement. This project's design has been completed and is pending approval of funding by the Board.
EQ Tank and Headworks Project	\$4,500,000 (Anticipated)	The EQ Tank and Headworks Project involves the installation of a new headworks as an upgrade to the current headworks at the KLWTD WWTP. This project also involves the installation of an influent EQ tank to regulate flow. This project is currently in the design phase with preliminary site plans and structural drawings for the EQ tank. Shop drawings have been received from Hydrodyne and a center flow screen has been selected for the headworks screening, which will reduce the footprint of the headworks space and has a higher catch rate and efficiency than the existing headworks.
Blower Room Modifications Project	\$250,000 (Anticipated)	The KLWTD staff has requested the addition of an access door behind blower #4 to better service the blower. Currently, the other blowers must be removed in order to access blower #4. These modifications will allow for more efficient service of the blowers. This project is currently in the preliminary design phase.

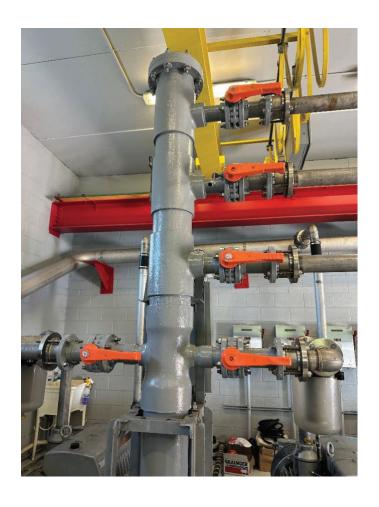

Re: Grinder Pump Lateral Kits Replacement Project

The District's FY24 budget includes the Grinder Pump Lateral Kits Upgrade Project. Each grinder pump station requires a check valve to prevent sewage from back-feeding from the force mains and a plug valve to allow for isolation of the individual grinder pump laterals from the force main systems.

Two types of check valves were installed as part of the C-905 and Unique Properties grinder pump programs. Some of the installed valves are manufactured in plastic and some brass. These were the standard valves recommended by E-One at that time. The District and other utilities in the Keys have been experiencing failures of these check valves. The plastic check valves have had mechanical failures with the check disks breaking loose and plugging the check valve discharge. The brass check valves have experienced corrosion of the brass bodies, causing leakage of sewage. The existing plug valves are manufactured in brass and are also experiencing corrosion and failures.

In addition to the above problems, the existing check valves and plug valves are buried at the depth at which the laterals were installed. In many cases, the valves are two feet or more below grade. To service or replace the valves, it is necessary to excavate down to the valves and work in the excavation, sometimes requiring dewatering of the hole. This required a backhoe and crew. The Grinder Pump Lateral Kits Upgrade Project includes installing the new 316 stainless steel lateral kits at a shallower depth and in meter boxes, allowing easy access without excavation for service and replacement.

A Bidder whose Bid, past performance, or current status that does not reflect the capability, integrity or reliability to perform fully and in good faith the requirements of the Contract may be rejected as non-responsible.
- 4.1.3 The KLWTD reserves the right to determine which Bids meet the material requirements of the ITB and which Bids are responsible and/or responsive. Further, the KLWTD may reject any and all Bids and seek new Bids when it is in the best interest of the KLWTD to do so.
- 4.1.4 A Bid by a corporation shall be executed in the corporate name by the president or a vice-president or other corporate officer accompanied by evidence of

authority to sign. The corporate seal shall be affixed and attested by the secretary or an assistant secretary. The corporate address and state of incorporation shall be provided on the Bid Form, for a Bid by a/an:

- a. Partnership shall be executed in the partnership name and signed by a partner (whose title must appear under the signature), accompanied by evidence of authority to sign. The official address of the partnership shall be provided on the Bid Form.
- b. Limited liability company shall be executed in the name of the firm by a member and accompanied by evidence of authority to sign. The state of formation of the firm and the official address of the firm shall be shown.
- c. Individual shall show the Bidder's name and business address.
- d. Bid by a joint venture shall be executed by each joint venture member in the manner indicated on the Bid form. The official address of the joint venture must be provided on the Bid Form.
- 4.1.5 All names shall be printed in ink below the signatures.
- 4.1.6 The Bid shall contain an acknowledgment of receipt of all Addenda, the numbers and dates of which shall be filled in on the Bid form. The Acknowledgement of Conditions form must also be completed verify that the Bidder has accessed, read and understands the requirements of the General Conditions, the KLWTD Supplementary Conditions and the FDEP Supplementary Conditions.
- 4.1.7 The postal and email addresses and telephone number for communication regarding the Bid shall be shown.
- 4.1.8 A Bidder seeking to do business with the KLWTD shall, at the time of submitting a Bid, be appropriately registered with the Department of State in accordance with the provisions of Chapters 605, 607, 617, or 620 Florida Statutes, as applicable. For further information on required filing and forms, please go to the following sites: <a href="http://www.sunbiz.org">http://www.dos.state.fl.us/doc/index.html</a>.

The Bid shall contain evidence of Bidder's authority and qualification to do business in the state or locality where the Project is located or Bidder shall covenant in writing to obtain such qualification prior to award of the Contract and attach such covenant to the Bid. Bidder's state contractor license number, if any, shall also be shown on the Bid Form.

#### 4.2 Instructions to Bidder

- 4.2.1 The Bid should address the requirements in a clear and concise manner in the order stated herein.
- 4.2.2 Bids must be tabbed as follows and must include the information/documents specified in the applicable tab. Bids that do not adhere to the following format or include the requested information/documents may be considered incomplete and therefore unresponsive by the KLWTD.
- 4.2.3 The KLWTD reserves the right to seek additional/supplemental representation on specific issues as needed.
- 4.2.4 Bids should be typed. No changes in or corrections to Bids will be allowed after the Bids are opened.
- 4.2.5 The signer of the Bid must declare that the Bid in all respects fair and in good faith without collusion or fraud and that the signer of the Bid has the authority to bind the principal Bidder.
- 4.2.6 The KLWTD shall not be liable for any costs incurred by Bidder prior to entering into a contract. Therefore, each Bidder is encouraged to provide a simple, straightforward, and concise description of their ability to meet the ITB requirements.

#### 4.3 BID CONSTRUCTION

Bidders shall construct its Bid in the following format as outlined and a tab must separate each section as prescribed.

The corporate or mailing address must match the company information as it is listed on the Florida Department of State Division of Corporations. Attach a copy of the web-page(s) from <a href="http://www.sunbiz.org">http://www.sunbiz.org</a> as certification of this required information. Verify that all addenda and tax identification number have been provided.

#### TAB 1 – QUALIFICATIONS, EXPERIENCE AND ABILITY OF PROFESSIONAL PERSONNEL

The Bidder shall provide a history of the organization, its areas of expertise and show the individual(s) providing these services will fulfill the needs of the KLWTD if awarded a contract pursuant to this ITB. Provide an organizational profile of the firm and five (5) years of experience for the "Work", and a list of

professional staff, years with the firm and a brief bio that may be assigned to a project and any professional certifications or licenses held.

#### TAB 2 – EXPERIENCE FOR SIMILAR PROJECTS

Provide a list of each similar project worked on within the last five years, which must include the project description, location, dates, and team members and must include the Qualification to Bid Application and Questionnaire.

#### TAB 4 - PROPOSED PRICING (ref: Appendix B-1)

Each Bidder shall use the Bid Form as provided as part of this ITB. All bid prices must be based on the approved activities as determined via the ITB documents. Pricing information must be submitted on the designated forms and signed by the appropriate parties. All addenda must also be acknowledged by the bidder.

#### **SECTION 5.0 BID OPENING**

5.1 All Bids will be opened on the date and time indicated in **Section 1.0, Schedule of Events** (i.e., date Bids are due) or as modified by addendum.

#### **SECTION 6.0 EVALUATION OF BIDS AND SELECTION PROCESS**

- 6.1 Bidder(s) who satisfy the required qualifications and are deemed responsible Bidder(s) and who timely submit a responsive Bid will be considered by the KLWTD.
- 6.2 The KLWTD may consider the following factors in addition to price when

determining whether a Bidder is responsive and responsible:

- a. Ability, capacity and skill of the Bidder to perform the contract.
- b. Whether the Bidder can perform the contract within the time specified, without delay, interference, or conflict with current workload.
- c. Character, integrity, reputation, judgment, experience and efficiency of the Bidder.
- d. Quality of performance of previous contracts.
- e. Previous and existing compliance by the vendor with laws and regulations relating to the contract.
- f. Sufficiency of the financial resources and ability of the vendor to perform the contract or provide the Work.
- g. Quality, availability and adaptability of the supplies or contractual services to the particular use required.
- h. Ability of the Bidder to provide further maintenance and service for the use of the subject of the contract, if applicable.
- i. Number and scope of conditions attached to the bid or quote.
- j. Qualifications of personnel, licensing and corporate qualifications.
- k. Evidence of improper litigation.
- I. Use of one or more subcontractors with a record of poor performance.
- 6.2.1 For the purposes of this section, the KLWTD may consider evidence from the five-year period preceding the subject bid.
- 6.2.2 In the event the lowest, responsive, responsible bid for a construction project exceeds the architectural or engineering cost estimates, the KLWTD administrator or designee is authorized, when time or economic considerations preclude rebidding of work of a reduced scope, to negotiate an adjustment of the scope of work with the lowest, responsive, responsible bidder, in order to bring the bid within the amount of available funds. After award of this Bid the KLWTD reserves the right to add or delete items/services at prices to be negotiated at the time of addition or deletion. At Contract renewal time(s) or in the event of significant industry wide market changes, the KLWTD may negotiate justified adjustments such as price, terms, etc., if in its sole judgment, the KLWTD considers such adjustments to be in its best interest.
- 6.3 The KLWTD reserves the right to reject any or all Bids, including without limitation, nonconforming, nonresponsive, unbalanced, or conditional Bids. The KLWTD further reserves the right to reject the Bid of any Bidder whom it finds, after reasonable inquiry and evaluation, to be non-responsible. The KLWTD also reserves the right to waive all informalities not involving price, time, or changes in the Work and to negotiate contract terms with the Successful Bidder.
- 6.3.1 More than one Bid for the same Work from an individual or entity under the same or different names will not be considered. Reasonable grounds for

believing that any Bidder has an interest in more than one Bid for the Work may be cause for disqualification of that Bidder and the rejection of all Bids in which that Bidder has an interest.

- 6.3.2 In evaluating Bids, the KLWTD will consider whether or not the Bids comply with the prescribed requirements, and such alternates, unit prices and other data, as may be requested in the Bid Form or prior to the Notice of Award.
- 6.3.3 In evaluating Bid, the KLWTD will consider the qualifications of Bidder and may consider the qualifications and experience of Subcontractors, Suppliers, and other individuals or entities proposed for those portions of the Work for which the identity of Subcontractors, Suppliers, and other individuals or entities must be submitted as provided in the Supplementary Conditions.
- 6.3.4 The KLWTD may conduct such investigations as the KLWTD deems necessary to establish the responsibility, qualifications, and financial ability of Bidder, proposed Subcontractors, Suppliers, individuals, or entities to perform the Work in accordance with the contract Documents. Any Bidder or sub-contractor that will have access to KLWTD facilities or property may be required to be screened to a level that may include, but is not limited to fingerprinting and a statewide criminal background check. There may be fees associated with these procedures. These costs are the responsibility of the Bidder or sub-contractor.
- 6.3.5 If the Contract is to be awarded, the KLWTD will award the Contract to the responsible Bidder who's Bid, conforming with all the material terms and conditions of the Instructions to Bidder, is lowest, price and other factors considered. If detailed in the bid form, factors such as discounts, transportation costs, and life cycle costs may be used to determine which Bidder, if any, is to offer the award.
- Responses to this ITB not meeting the requirements specified herein will be considered non-responsive or not responsible, as applicable. The KLWTD reserves the right to reject any and all responses or waive any minor irregularity or technicality in responses received. Bidders are cautioned to make no assumptions unless their response has been deemed responsive.
- 6.5 Whenever two or more Bids, which are equal with respect to price, quality and service, are received for procurement of commodities or contractual services, from responsive and responsible Bidders the following steps will be taken to establish the award to the lowest Bidder. This method shall be used for all ties.

#### Step 1 - Local Business:

Between a Local Business and a Non-Local Business, a Contract award, or the first opportunity to negotiate, as applicable, shall be made to the Local Business.

#### Step 2 Drug Free Workplace:

At the conclusion of step 1 if all is equal, the Bidder with a Drug Free Workplace program shall be given preference, over a Bidder with no Drug Free Workplace program. The Contract award, or the first opportunity to negotiate, as applicable, shall be made to the Bidder with the Drug Free Workplace program. In order to have a drug free workplace program, a business shall comply with the requirements of § 287.087, F.S.

#### Step 3 Coin Flip:

At the conclusion of Step 1, and Step 2 if all is equal, the Contract award, or the first opportunity to negotiate, as applicable, shall be determined by the flip of a coin to determine final outcome.

- 6.5.1 When the tie has been broken pursuant to the above procedures, the Contract award, or the first opportunity to negotiate, as applicable, shall be made.
- 6.5.2 If an award or negotiation is unsuccessful with the initial Bidder, award or negotiations may commence with the next lowest Bidder, utilizing the tiebreaker steps above to make the determination of next lowest Bidder if necessary.
- 6.6 When the KLWTD gives a Notice of Award to the Successful Bidder, it shall be accompanied by the required number of unsigned counterparts of the Contract with the other Contract Documents which are identified in the Contract as attached thereto. Within two (2) days thereafter, Successful Bidder shall sign and deliver the required number of counterparts of the Contract and attached documents to the KLWTD. The KLWTD shall deliver one fully signed counterpart to Successful Bidder with a complete set of the Drawings with appropriate identification.

#### SECTION 7.0 INTENT TO AWARD AND CONTRACT EXECUTION

- 7.1 The KLWTD reserves the right to incorporate the successful Bid into the Contract. Failure of a Bidder to accept this obligation may result in the cancellation of the award. The Draft Agreement and its exhibits are included as Appendix D, which is attached hereto and incorporated herein by reference.
- 7.2 The construction, interpretation, and performance of this ITB, and all transactions under it shall be governed by the laws of the State of Florida and

the KLWTD. The Contract shall include all terms and conditions of this ITB, any addenda, response, and the KLWTD's contract issued as a result of this ITB.

- 7.3 The KLWTD reserves the right to make award(s) by individual item, group of items, all or none, or a combination thereof. The KLWTD reserves the right to reject any and all bids or to waive any minor irregularity or technicality in the bids received. Award will be made to the lowest responsible and responsive Bidder(s) within the category chosen for basis of award. The KLWTD reserves the right to award to one or multiple Bidder(s) at its discretion.
- 7.4 The Successful Bidder will be required to assume responsibility for all services offered in the Bid. The KLWTD will consider the Successful Bidder to be the sole point of contact with regard to contractual matters, including payment on any or all charges.
- 7.5 After successful posting of the award for 72 hours, the Successful Bidder will be required to enter into the Contract with the KLWTD.

#### 8.1 Definitions

General terms used throughout this ITB are provided below. Additional definitions may be provided as applicable to a specific section or subject matter.

**Award** means the determination of a successful Bidder(s) in response to this ITB, resulting in an offer of a Contract to perform the services pursuant to the ITB and their bid.

**KLWTD** means the KLWTD Commissioners and its employees.

**Contract** means the legally enforceable document agreed to and signed by the KLWTD and successful Bidder(s) (collectively referred to as the "Parties"), a draft Contract is attached hereto as Appendix D and incorporated herein.

*ITB* means this document, its attachments and any document hereinafter incorporated by reference.

**Bidder** means any firm, individual or organization submitting a Bid in response to this ITB.

**Successful Bidder** means a Bidder who is Awarded a Contract as result of the Bid submitted in response to this ITB.

**Bid Bond** means an insurance agreement in which a third party agrees to be liable to pay a certain amount of money in the event that a selected vendor fails to accept the contract as bid. If required, a bid bond/deposit shall be for 5% of the amount of the bid.

**Payment Bond** means a bond which assures that the subcontractors, laborers, and material suppliers will receive payment for the services and products used to fulfill the contract.

**Performance Bond** means a bond to assure satisfactory performance of the terms of the contract.

**Work** or **SOW** means the scope of work and/or services.

**Engineer** means the engineer/engineering firm responsible for preparing the Construction Drawings and Specifications.

**Local Business** means a business that has a current business tax receipt issued by Monroe County, Florida, if required, and has its principal office located within the State of Florida currently and for the six (6) month period immediately preceding submission of a response to a Competitive Procurement.

#### 8.2 Florida Public Records Law and Confidentiality

- 8.2.1. By submitting a Bid in response to this ITB, a Bidder acknowledges that the KLWTD is a governmental entity subject to the Florida Public Records Law (Chapter 119, Florida Statutes). The Bidder further acknowledges that any materials or documents provided to the KLWTD may be "public records" and, as such, may be subject to disclosure to, and copying by, the public unless otherwise specifically exempt by Law.
- 8.2.2 Should the Bidder provide the KLWTD with any materials which it believes, in good faith, contain information that would be exempt from disclosure or copying under Florida Law; the Bidder shall indicate that belief by typing or printing, in bold letters, the phrase "PROPRIETARY INFORMATION" on the face of each affected page of such materials. The Bidder shall submit to the KLWTD both a complete copy of such material and a redacted copy in which the exempt information on each affected page, and only such exempt information, has been rendered unreadable. In the event a Bidder fails to submit both copies of such material, the copy submitted will be deemed a public record subject to disclosure and copying regardless of any annotations to the contrary on the face of such document or any page(s) thereof.
- 8.2.3 Should any person request to examine or copy any material so designated, and provided the affected Bidder has otherwise fully complied with this provision, the KLWTD, in reliance on the representations of the Bidder, will produce for

that person only the redacted version of the affected materials. If the person requests to examine or copy the complete version of the affected material, the KLWTD shall notify the Bidder of that request, and the Bidder shall reply to such notification, in writing that must be received by the KLWTD no later than 4:00 p.m., EST, of the KLWTD business day following Bidder's receipt of such notification, either permitting or refusing to permit such disclosure or copying.

8.2.4 Failure to provide a timely written reply shall be deemed consent to disclosure and copying of the complete copy of such material. If the Bidder refuses to permit disclosure or copying, the Bidder agrees to, and shall, hold harmless and indemnify the KLWTD for all expenses, costs, damages, and penalties of any kind whatsoever which may be incurred by the KLWTD, or assessed or awarded against the KLWTD, in regard to the KLWTD's refusal to permit disclosure or copying of such material. If litigation is filed in relation to such request and the Bidder is not initially named as a party, the Bidder shall promptly seek to intervene as a defendant in such litigation to defend its claim regarding the confidentiality of such material. This provision shall take precedence over any provisions or conditions of any Bid submitted by a Bidder in response to this ITB and shall constitute the KLWTD's sole obligation with regard to maintaining confidentiality of any document, material, or information submitted to the KLWTD.

#### 8.3 Procurement Challenges

Any Bidder who desires to formally protest shall follow the procedures outlined in Appendix D and Appendix E.

#### 8.4 Construction and Venue

The validity, construction, and effect of this ITB and subsequent Contract shall be governed by the Laws of the State of Florida. The provisions of the ITB, Successful Bidder's Bid and subsequent Contract shall be complied with by the Parties, but only to the extent they are consistent with applicable law and the Contract. In the event of an inconsistency, the Order of Precedence shall be followed:

- a. Laws of Florida and Contract
- b. ITB and all of its addendums and attachments
- c. Successful firm's Bid

Venue for all actions arising under the ITB and subsequent Contract shall lie in Monroe County, Florida, United States.

#### 8.5 Contract

8.5.1 The Successful Bidder will be required to enter into the Contract withthe KLWTD and will be required to perform the Work in accordance with the Contract terms and conditions. The Draft Agreement is attached hereto as Appendix C and

incorporated herein by reference.

8.5.2 Any exceptions to the Draft Agreement must be noted on the Bid Form (Appendix B-1). The KLWTD is under no obligation to modify the Draft Agreement to conform to the Successful Bidder's exceptions. Contingent Bids will not be accepted. If acceptance of the Contract Award is contingent on an exception and modification to the Contract, the Bidder must provide this information to the KLWTD at the time of submission of technical questions, as outlined in the Schedule of Events in order to obtain a determination from the KLWTD regarding the proposed exception. If a Bidder's exception and modification are rejected by the KLWTD during the technical question portion of the Bid process and the Bidder later submits a Bid, Bidder shall be deemed to have accepted this Agreement provision.

#### 8.6 Insurance Requirements

8.6.1 Insurance Requirements – See Appendix D and E.
