# Background

- Raftelis performed a Rate Study in 2019
  - Developed financial model comprising budget + 10-year financial forecast
  - Resulted in adoption of a 15% reduction in retail rates effective January 1, 2020
  - Study identified need for rate indexing by fiscal year 2025 to keep pace with inflation in operating costs
  - Recommended updating the study every 3-5 years or as conditions change



# Background - Key Changes Since 2019 Rate Study

- Cashflow Differences:
  - > Retail rate revenues approximately 5% greater
  - Operating Costs are 10% greater than
- Capital and Grants:
  - CIP is \$20m greater over forecast period, however projected to received greater amount of grant funding
    - Offset by \$2.0 million/yr in Annual ACOE grant funding (\$22 million over forecast)
  - Additional Stewardship grant funding of \$9.9 million
- Debt Service:
  - District paid off a significant amount of debt; 1 SRF loan remaining maturing in FY29
  - Projected outstanding balance at EOFY22: \$9.65 million @ Interest rate of 2.5%
- Unrestricted cash balances are \$1m greater than prior study at 9/30/21
- Key takeaway: while inflation and CIP spending are higher the District has outperformed with greater revenues and increased grant funding / cash reserves

- Primary Study Objectives:

  - > Present Rate Options
  - Seek direction from Board

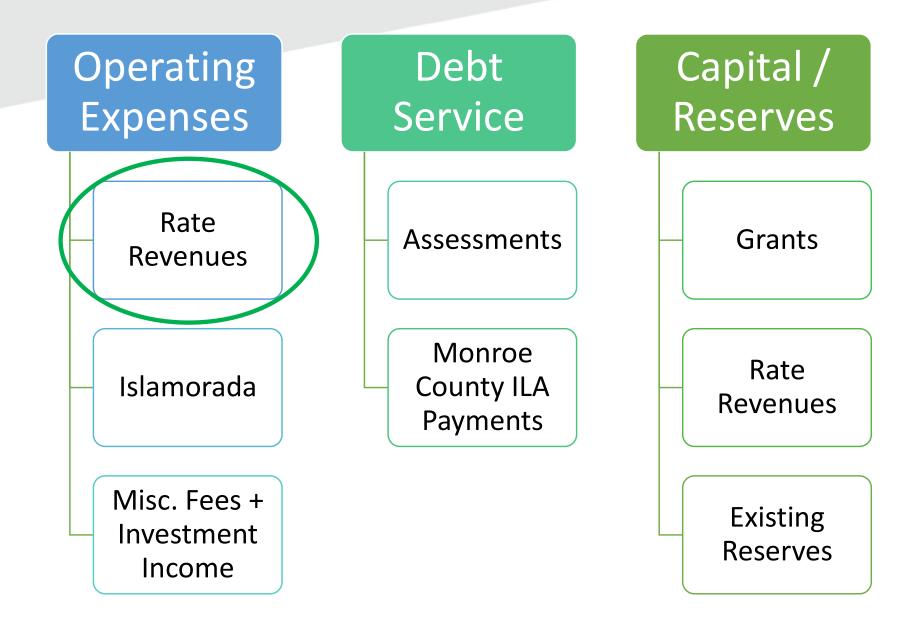

# **Options Analysis**

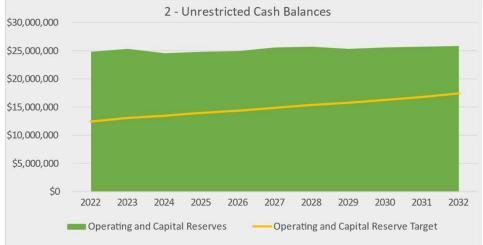
- All options set rates to at least recover operating expenses over the forecast period
  - Assumes that grants and cash reserves will provide majority of capital funding
- Original FY19 Rate Plan Assumed Indexing in FY25
- Examined 2 Rate Option Proposals:
  - Option 1
    - 3.5% Annual Indexing
    - Delayed from FY25 in FY19 Study to FY26
  - Option 2
    - FY23 5% reduction
    - 3.5% indexing starting in FY25

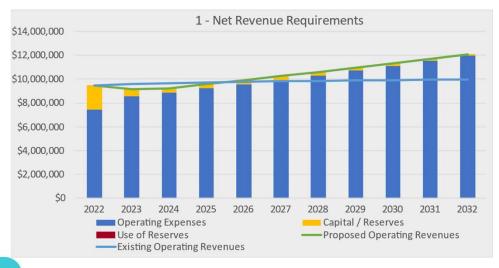


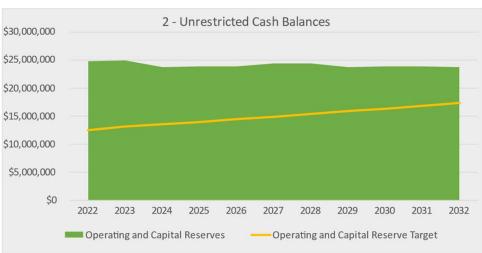

### Conclusions

- All rate options fully fund projected revenue requirements
- Current projections outperformed prior forecast overall
- District's cash reserves allow the District flexibility to reduce or defer rate increases for the benefit of existing rate payers
  - Recommended Option (w/ Rate Reduction) still provides sufficient cash reserves maintaining ability to react and adjust rates as needed if current forecasts underperform
- Recommend the District review the revenue requirements Prior to Indexing (2 Years)

#### **ATTACHMENT**

<u>EDU Assignment:</u> KLWTD Rules and Regulations provide that each non-residential tax parcel shall be assigned 1 EDU for 167 gallons per day (GPD). The District estimates water usage from the new structure to be 729 GPD for a total of 4.4 EDUs.

<u>Previous System Development Charges:</u> The four properties were previously assigned 1 EDU each in the amount of \$5,200 for a total SDC assessment of \$20,800 during 2008. During 2009 a request to waive the EDU Assignments for AK No's. 1639761, 1639770, and 1639788 was initiated, no payments were made to the SDC. AK No. 1639753 was kept on the assessment roll until 2015 the owner then requested to waive the EDU assignment. The staff has determined payments of \$2,938.23 were paid before the waiver was approved in 2015. The District has applied a credit to the SDC for \$2,938.23 to the overall balance.

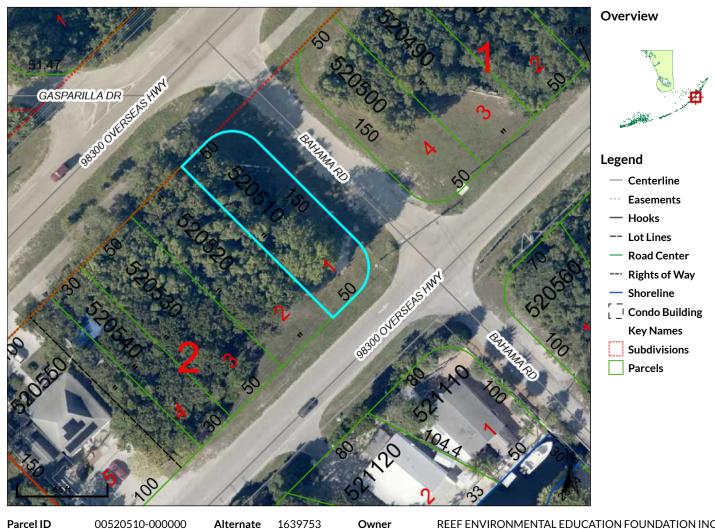

Note, meters coded as Fire or Irrigation are not charged for wastewater.

If no building on the premises is capable of generating wastewater, you may apply for a temporary deferral of wastewater monthly billing. 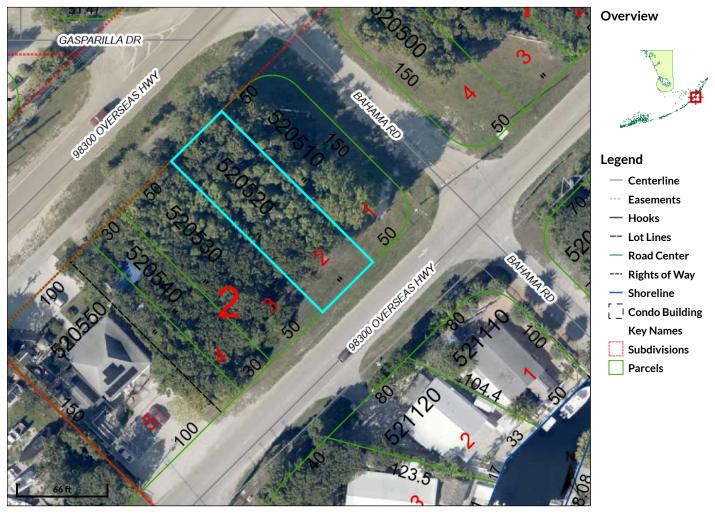

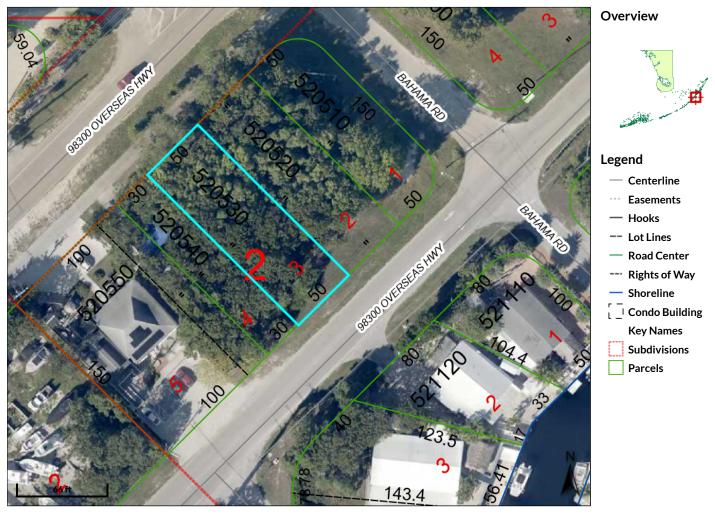

Please be advised that the Key Largo Wastewater Treatment District's ("District") Board of Commissioners ("Board") will consider imposing a System Impact Charge ("SIC") for the above-referenced parcel at its next regularly scheduled meeting on May 7, 2024

The SIC is a charge to customers who construct facilities that impose a potential increased demand on the District's wastewater facilities. The SIC is the sum of the System Development Charge ("SDC") plus any additional direct or indirect fees incurred by the District to extend service to your parcel.

Your design plans indicate your proposed project will result in an increased demand on the District wastewater facilities.

If approved by the Board, the following changes will be made to your account:

<u>EDU Assignment:</u> Your parcel's EDU assignment, which is used to calculate the SIC and wastewater base charge, will be increased from 18.2 EDUs to 26.10 EDUs. See Attachment for calculations.

Additional Fees: Currently there are no additional fees.

<u>Total SIC Charge</u>: \$34,017.40. Payment is due in full prior to the time of imposition (Board approval.) A deposit of \$10,000 has been paid to the District on April 26, 2024. See Attachment for calculations.

<u>Wastewater Base Charge:</u> The wastewater base charge, billed monthly by the Florida Keys Aqueduct Authority ("FKAA"), will be increased from \$493.76 to \$708.09. See Attachment for calculations.

<u>EDU Assignment:</u> KLWTD Rules and Regulations provide that each non-residential tax parcel shall be assigned 1 EDU for 167 gallons per day (GPD). The District estimates water usage from the additional structure to be 1,320 GPD for a total of 7.9 EDUs.

<u>Previous System Development Charges:</u> Your property was previously assigned 18.2 EDUs for a total SDC assessment of \$55,940.00. The SDC has been reduced by previous payments in the amount of \$44,752.00 leaving a remaining assessment balance due of \$11,188.00. You may opt to pay that balance in full or continue making annual payments on the Annual Tax Bill from the Monroe County Tax Collector.

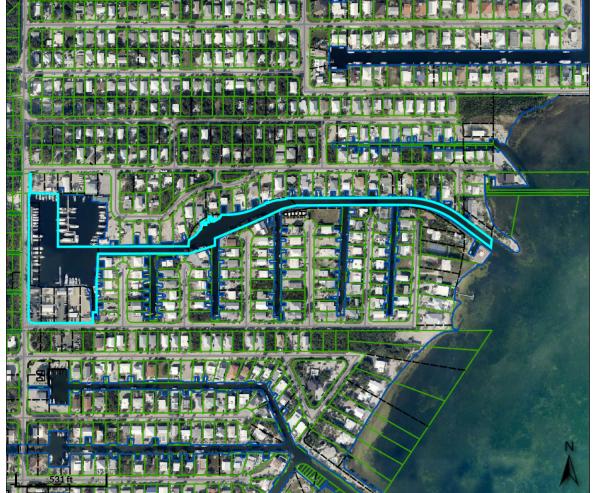
